If your research requires access to news from a variety of print and online sources, try FACTIVA, the premium global news database from Dow Jones/News Corp. Available through the <u>Library's subscription</u> (login required off campus), FACTIVA includes searchable content from nearly 33,000 news sources across the world, including newspapers, trade journals, influential websites, blogs, images, and videos. 74% of FACTIVA's sources are not available on the free web, and many articles are available on or before the date of publication. Visualization and analysis tools, suggested search terms and related results, and features like date, region, industry, and language filters are easy to use and take much of the time and imprecision out of news-oriented research.
