**AUTHOR/JOURNAL PUBLICATION AGREEMENT**

The following is an Agreement between NANTIYA RUAN (the "Author") and WASHINGTON AND LEE UNIVERSITY ("W&L") on behalf of the *Washington and Lee Journal of Civil Rights and Social Justice*, a journal owned by Washington and Lee University (the "Journal"), and governs;

Forthcoming Work, Titled *Corporate Masters and Low Wage Servants* for the Fall Book 2017 (the "Work").

1. The Author's Grant of Rights:

- a. Except as provided in Paragraphs 1(c) and 2(b), the Author grants to W&L the rights to reproduce and distribute the Work in the Journal, in facsimile reprints or microforms, as a contribution to a collection published by W&L, and by means of an Internet or Intranet site over which W&L exercises effective control, and also by means of a third-party online legal information provider, such as, but not limited to, LEXIS-NEXIS and Westlaw.
- b. The W&L rights provided in Paragraph 1(a) shall be non-exclusive beginning from the date of execution of this Agreement.
- c. After the Work has been published in the Journal, W&L shall have the right, after notification of the Author, to authorize another party to reproduce and distribute the Work in the forms specified in Paragraph 1(a).
- d. The Author grants the above rights without claim of royalties or other compensation.
- e. The Author certifies that the Work contains no material that infringes the copyright of any other person. If the contribution contains material which is someone else's copyright, the Author promises that the unrestricted permission of the copyright owner to reproduce the material has been obtained and that the material is clearly identified and acknowledged in the text. The Author additionally certifies that the Work is substantially the Author's own work product and the work of third parties in the Work to this Agreement are adequately cited.

2. The Author's Ownership of Copyright and Reservation of Rights:

- a. The copyright in the Work shall remain with the Author.
- b. The Author retains the rights:
  - (i) To reproduce and distribute the Work, and to authorize others to reproduce and distribute the Work, in any format, to students for classroom use, at or below cost;

(ii) To include the Work, in whole or part, in another work of which the Author is the sole or joint author or editor, provided that in either circumstance if the Author submits a work for publication that is substantially the same as the Work to another periodical that such work identifies the Author, W&L, the volume, the number of the first page, and the year of the Work's publication in the Journal; and

(iii) To post the Work, in whole or in part, on an Internet or Intranet site over which the Author has effective control provided that such Work identifies the Author, W&L, the volume, the number of the first page, and the year of the Work's publication in the Journal. The Author shall also provide a hypertext link to a copy of the Work on an Internet or Intranet site over which W&L exercises effective control. This provision includes postings on Social Science Research Network (SSRN). W&L will provide a PDF or other electronic version of the Work in its final form on the Washington and Lee Digital Repository, and requests that the Author provide this link for all other Internet or Intranet sites.

3. Publication by Others:

- a. Unless the Author notifies W&L in writing otherwise, the issue of the Journal in which the Work appears shall include a notice stating that the Work may be reproduced and distributed, in whole or in part, by nonprofit institutions for educational purposes including distribution to students, provided that the copies are distributed at or below cost and identify the Author, W&L, the volume, the number of the first page, and the year of the Work's publication.
- b. W&L shall have the right to authorize another party to reproduce and distribute the Work in a form other than those specified in Paragraph 1(a), provided that such reproduction identifies the Author, W&L, the volume, the number of the first page, and the year of the Work's publication, and provided further that the Author has been notified by W&L of its intent to authorize such reproduction and distribution not less than thirty (30) days prior to the grant of such authorization and the Author has not within thirty (30) days after being notified given W&L written notice of the Author's objection to such reproduction and distribution.

4. Abstract, Editing, and Printing:

- a. The Author shall, prior to publication of the Work by the JCRSJ, prepare and submit to W&L an abstract of the Work (the Abstract), not exceeding 300 words in length, and the rights of W&L to the Abstract shall be governed by Paragraph 1 of this Agreement. If the Abstract of the Work exceeds 300 words, the Author authorizes W&L to edit the Abstract for length. If the Author does not submit the Abstract, the Author authorizes W&L to prepare the Abstract.
- b. The Author authorizes W&L to edit and revise the Abstract and the Work prior to publication in the Journal, but W&L shall not publish the Abstract or the Work unless it is acceptable in its final form to both the Author and the W&L.
- c. Provided that the Fall Book 2017 of the Journal is published in print, the W&L

shall give the Author, without charge, 15 offprint copies of the Work promptly after publication and, if requested by the Author, additional copies at a cost to be determined. If the Fall 2017 Book of the Journal is not published in print, W&L shall give the Author 15 offprint copies of the Work at a cost to be determined.


- d. Should the name of the Work change during the editing process, but before publication, (i) such a change will not void this agreement and (ii) the author shall notify W&L of the intent to change the title within the time allotted for Author review.

5. Final Agreement:

This Agreement constitutes the whole and sole agreement between the Author and W&L with respect to the publication and copyright of the Work. Any modifications or additions to the terms of this Agreement shall be in writing.
