LAW SCHOOL NOTES

Faculty. Dean Clayton E. Williams has announced his retirement as dean, effective this summer. Professor Charles P. Light, Jr., will succeed him as dean. Mr. Williams will continue to teach during the 1960-61 academic year as Distinguished Lecturer in the Law of Property. Professor Charles R. McDowell has been named Bradford Professor of Law. Assistant Professor Robert R. Huntley has been promoted to Associate Professor.

Tucker Lectures. Ross L. Malone, immediate past President of the American Bar Association and senior partner in the firm of Atwood and Malone in Roswell, New Mexico, will deliver the Tucker Lectures on April 15 and 16. Mr. Malone is an alumnus of Washington and Lee Law School.
